### President's Report 2018/19

Although the club saw a drop in registrations from 31 to 22 this year the Half Marathon organized from the club was a huge success building on the event from 2018 after missing the 2017 event. Reuben Caley took on the event organization this year with great help from Robbie Costmeyer and Philo Saunders. The 10km community fun run was continued.

The 33<sup>rd</sup> running of this iconic Canberra running event was conducted on Sunday 17 March 2019 in perfect weather. For the first time in the event's illustrious and long history we used electronic timing. Distinctive timing bibs for each race had been purchased and a number of overseas runners bought their bib after the race to keep as a souvenir. The timing system worked well and we will keep that feature as part of our future events. Electronic timing allowed us to upload results onto our Facebook page in real time for the first time. We also introduced engraved Canberra Redbacks medals for the second and third runners in the half marathon and for the each of the 10 year age group winners. The male and female winners of the half marathon got to hold the perpetual trophy for a little while and then returned it to have their names engraved on it. They each received an engraved 'keepsake' trophy. The Half Marathon had 138 finishers up by 77 from 2018. The 10km run had 48 finishers up by 17 from 2018. All up the event made the club a profit of some \$9000 and the event only seems to be getting stronger.

The club held the annual Life Members Dinner at Bellavista in Belconnen, which was a great success. This event allows current members to recognise the previous club members who formed and grew the club. This is always a great opportunity to share stories and give members ideas for the futures of the club. The dinner was well attended with many life members attending.

The Club is in a reasonable position members-wise although it would be nice to get membership up a bit next year. The revenue generated from the annual half marathon along with an enthusiastic and active Committee is continuing to make the Club relevant and having the ability to support its members.

The liability listed on the balance sheet is for the donations collected from the participants in the 2019 Half Marathon for Hartley Lifecare. At the end of the financial year the donations had not been forwarded to Hartley Lifecare. These donations will be forwarded to Hartley Lifecare shortly.

The club paid out a healthy amount in subsidies to our athletes of \$2,030 in the 2018/19 financial year. This figure was a lot higher than in 2017/18 (\$1,296) but very similar to the amount paid out in 2016/17 (\$2,060).

The Club was in a healthy financial state on 31/3/2019 with \$20,898.02 in its cheque account.
